Note No. 10: Significant Accounting Policies and Notes on Accounts:

- 1. OVERVIEW OF THE SOCIETY'S OPERATIONS: In conformity with its aims and objects, the Society
 - To Promote and protect the medium, Small & Tiny Industries and Micro Enterprises.
 - To take all steps to protect and promote the general interests of the persons engaged in Medium,
 Small & Tiny Industries and Micro Enterprises.
 - To Provide Consultancy Services to Govt, Government agencies, Public Sector Organisations, NGO and Private Sector.
 - To Consider and formulate opinions upon all matters connected with the Medium, small and Tiny Industries and Micro Enterprises.
 - To adjust and settle disputes or controversies between the member of the association.
 - To Organise and establish vocational Institutes where theoretical and practical training will be provided.
 - To Maintain a list of skilled workmen and to get into contact with small scale Industrial Establishment all over the country and to provide suitable employment for such persons.

2. SIGNIFICANT ACCOUNTING POLICIES

- a. BASIS OF ACCOUNTING: The financial statements have been prepared to comply in all material respects in respects with the accounting standards issued by the Institute of Chartered Accountants of India ('ICAI'),. The financial statements have been prepared under the historical cost convention and on accrual basis except stated otherwise. The accounting policies have been consistently applied by the society and except for the changes in accounting policy discussed more fully below, are consistent with those used in the previous year.
- b. REVENUE/EXPENDITURE RECOGNITION: Grants received for specific purposes are initially treated as a liability and adjusted for capital or revenue expenses as per utilization during the year. Generally, grants to the extent utilized for revenue expenditure are treated as income of the year. After fulfillment of obligations attached with a particular grant, any unutilized amount not refundable to the donor and/or charged to the donor as per terms of the respective agreements is transferred to the Income and Expenditure account.
- c. FORMAT OF ACCOUNTS: The Income and Expenditure has been classified based on the natural head of expense, though in funding agency wise Income and Expenditure Accounts are classified based on line item of expenses as per funding agency project activities.
- d. TREATMENT OF ASSETS: Fixed assets are stated at Cost, after reducing opening accumulated depreciation. Acquisitions of assets though they are charged to the Funding Agency's grants are retained in the books by creating a Capital Asset Fund. Direct Costs are capitalized until the assets are ready for use.

3. NOTES ON ACCOUNTS

a. Fixed Assets: During the year the Society has acquired Fixed Assets of Rs. 38,48,757/-(Previous Year Rs. 44,56,831/-) and depreciation is provided on fixed assets held by the Society is Rs.-7,38,074/- (Previous year Rs.8,25,016/-).
